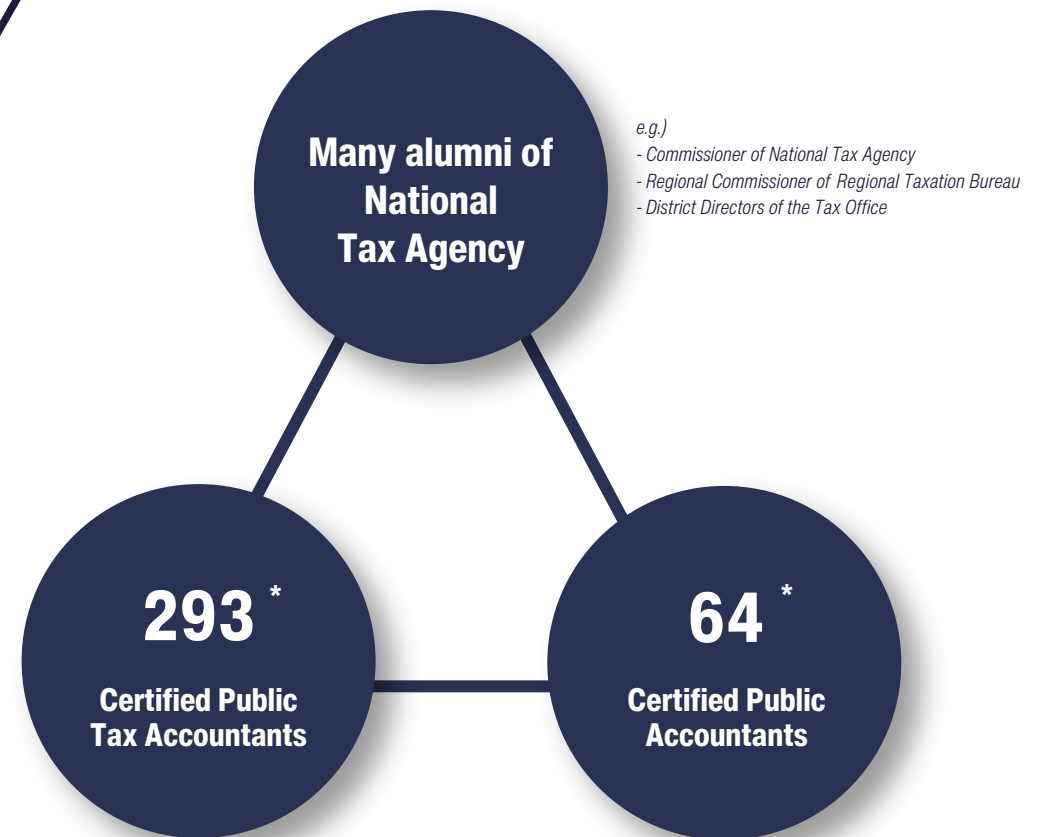

What's the issue?

As the business expanded, the workload of the accounting department increased. As a result, the employees who had been in charge of accounting work had to deal with customers, and there was a shortage of personnel for accounting and settlement work. As a result, monthly settlement of accounts has been delayed, making it difficult to grasp profits and losses in a timely manner.
